4. FIRST AID MEASURES

General information:

If exposure to internal materials within battery due to damaged outer casing, the following actions are recommended.

After inhalation:

Supply fresh air and to be sure call for a doctor. In case of unconsciousness place patient stably in side position for transportation.

- After skin contact: Rinse with water.
- After eye contact: Rinse opened eye for several minutes under running water. Then consult a doctor.
- After swallowing: Drink plenty of water and provide fresh air. Call for a doctor immediately.

5. FIRE FIGHTING MEASURES

Suitable extinguishing agents: CO₂, powder or water spray. Fight larger fires with water spray or alcohol resistant foam.

Protective equipment: Wear fully protective suit.

6. ACCIDENTAL RELEASE MEASURES

Person-related safety precautions: Wear protective equipment. Keep unprotected persons away.

Measures for environmental protection:

- Do not allow product to reach sewage system or any water sourse.
- Inform respective authorities in case of seepage into water course or sewage system.

If battery casing is dismantled, small amounts of electrolyte may leak. Collect all released material in a plastic lined container. Dispose off according to the local law and rules. Avoid leached substances to get into the earth, canalization or waters. Pick up and transfer to properly labeled containers.
